

PRODUCT SHOW



Legislative Report

This months legislative report will continue to compare the design differences of the major sections of the Massachusetts State Plumbing Code (248 CMR 10.00) to that of the international plumbing code (IPC).


This month's article will review the Plumbing Fixtures sections of the two codes.

Both codes approve and disapprove the same type of fixtures and present similar materials and design requirements for each type of plumbing fixture. The IPC separately list materials for specialty fixtures in section 402.2. The codes vary in the minimum facilities requirement. Overall, when comparing IPC table 403.1 with 248 CMR 10.10 table 1, the IPC is less stringent than 248 CMR requirements. The IPC also does not state a urinal requirement within table 403.1, it refers you to 419.2., witch states that "urinals shall not be substituted for more than 67 percent of the required water closets". In addition, the mass code allows for the substituting of urinals for water closets when determining the minimum required fixtures, but the percent is different for each building classification. In 248 CMR, the separate facilities requirement also varies with each building classification, but the IPC allows for combined facilities for occupancies where fifteen or less people are employed. Also, the IPC allows fixtures within a unisex toilet and bathing room to be included in the minimum facilities requirement for the assembly and mercantile occupancies.

Another area the two codes vary is alternative technology. 248 CMR 10.5F allows the use of "innovative and alternate technology toilets" in areas where sewers are unavailable.
