

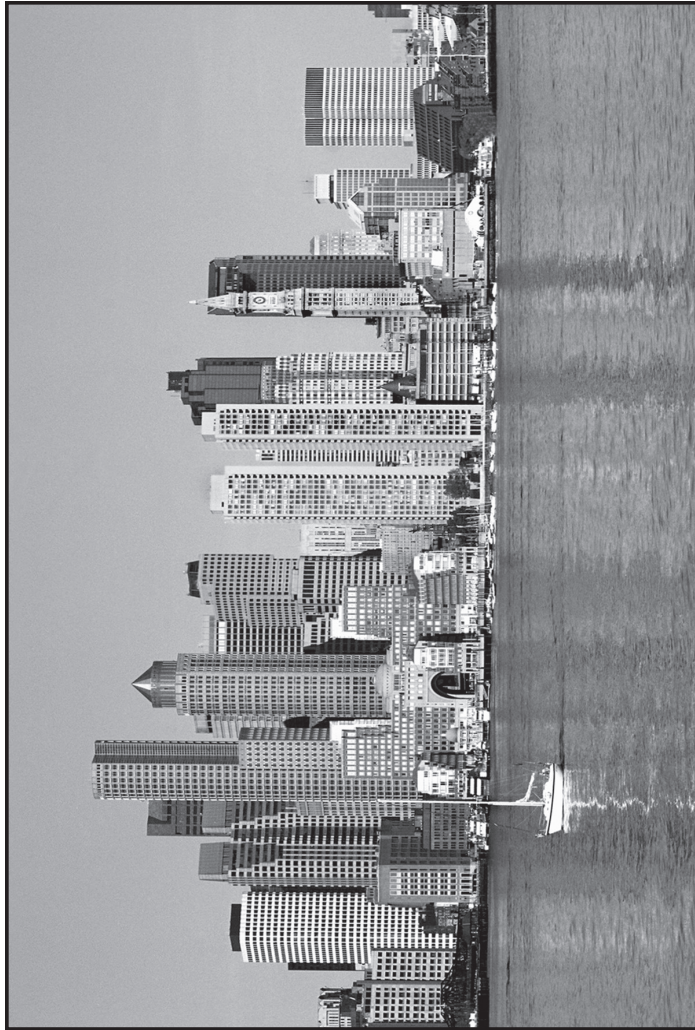

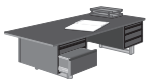

REGARDING SOME OF THE HISTORY OF THE BOSTON CHAPTER

Before the Boston Chapter was created a group of engineers, designers, affiliates, and contractors had several meetings at the Colonnade Hotel in Boston. These meetings were conducted by Samuel Ussia, PE. At that time, the American Society of Plumbing Engineer was only 9 years old. The group who met at the Colonnade decided to become the Boston Chapter in 1972 and we were chartered in 1973. Where have 37 plus years gone?

The Society was incorporated at Los Angeles, California and the first President was Donald Dickerson, PE.

After the Charter presentation by the Society President George Runkle, PE at the Quincy Neighborhood Club, the Chapter President Samuel Ussia, PE suggested the regular monthly meetings be held at the prestigious Engineers Club located at the Prudential Tower in Boston. After a few years, President Evan Bailey, PE moved the monthly meetings to Blin-

Technical Report

A great start to a New Year

On behalf of the Boston Chapter Board of Directors I want to thank Julie Paquette, PE, LEED AP for the January technical presentation. Julie described the updates to the LEED V3 system, and then focused on the importance of a plumbing engineer's role in the process of LEED certification and sustainability. A point of discussion was the usages of water in our society; agriculture is the biggest use with domestic usages as a fraction of that. The presentation also included a discussion of various plumbing fixture selections and other water conservation methods. She gave an example of general low flow fixtures and then compared them with high efficiency technologies (HET). The result of this example was the varying degree of water savings. The impact of using these HET fixtures does have some drawbacks, i.e. Drain line carry is reduced. The questions and discussion that followed were quite insightful, this despite the small audience.

February Monthly Chapter Meeting

This month we will be hosting the annual joint meeting with the Plumbing Heating and Cooling Contractors (PHCC) at the Lantana. The joint meeting's topic will be Massachusetts Plumbing Code updates. The primary focus will be on policy decisions the State Board has recently ruled on. There have been many changes to what initially appears to be subtle code issues; these unfortunately come at late points in many of our projects. This is an opportunity to get a better understanding of the policies of the State Plumbing Board. I encourage you to attend and hopefully you will be able to gain a better understanding of the code that impacts our efforts on a daily basis.

Upcoming Chapter Events:

The chapter is targeting the month of March to start the Plumbing Fundamentals classes. The purpose of this series of classes is to facilitate a thorough understanding of plumbing design fundamentals. Blair Chamberlain, PE, our Education Chairman, is spearheading this effort and has reached out to those who had previously expressed interest. Blair is also looking for volunteers to teach different segments; if you are interested in giving some of your time please contact Blair.

The Revit/BIM seminar is target to take place in May of this year. This particular month was chosen so as to not conflict with the upcoming CPD test (April 15 and 16). This seminar will be designed to provide the attendee with an exposure to more advanced topics in using BIM software.

strub's (now Phillips Old Colony Club House) located on Old Colony Boulevard in Dorchester. We continued with our monthly meetings and celebrated our success at the Christmas Parties and the end of the year dinner dances with our wives and/or girlfriends. Both events were very well attended and financially successful.

Did you ever wonder what the ASPE logo represents? The design represents various aspects of the Plumbing industry. The letters ASPE (for the Society name) are superimposed over a slide rule (representing engineering), laid over a triangle (representing design-drafting) over the end of a pipe (representing sales representatives and contractors), with a blue block background (representing a blueprint). Keep in mind the logo was designed before we had calculators, computers or computer-aided drafting. There have been many attempts to change the logo yet each attempt has failed.

The Chapter has not always been financially successful as we are today. During President Robert Hough's, PE administration it was not uncommon that they would pass the hat to collect enough money to pay for postage. During President Bernard J. McCarty's administration the Board of Directors put up their own money to keep the Chapter solvent. They did this for the love of the Chapter, for they refused to let the Chapter fail because of finances.

The Chapter realized we could not function on dues rebates or lastly passing the hat. The start and continued success of our product shows is part of the reason our Chapter still exists. With the help of Affiliates like John Diohep, Bob Smith, Chuck Henry, Bill Adelson and many, many more, the first Product show was held at the Howard Johnson 57 Stuart Street (now the Radisson Hotel). The show was a success but the ballroom was too small for the number of vendors who did not display but were asking to be included in the next show. The Chapter investigated many places before settling on The Lantana in Randolph, MA. President Allen Sterns, PE suggested we move our monthly meetings to The Lantana where we have been for more than thirty years. The banner years continued and in fact they got better. We averaged almost 75 members and guests per meeting, and we continued to have our well attended Christmas Parties and end of the year Socials.

The ASPE Conventions have been in different cities since 1966. This has been quite an experience for me, not only did I learn about advance Plumbing technologies at the seminars but the Engineered Plumbing Exposition was loaded with 200 to 300 booths. The Society's successful Exposition now boasts 800 to 1000 booths. But one of the most endearing things to me was and still is meeting Plumbing engineers, designers and vendors from all over the country. These attendees have become close friends of my wife and I. We are looking forward to attending the ASPE convention in Philadelphia, PA, to learn more about Plumbing technologies and reunite with old friends and hopefully meet new ones.

The Society has held Symposia a.k.a. ASPE University in smaller cities throughout the country. The symposia were stated to provide Plumbing technology lectures, distribute Chapter and individual awards and allow the Society to keep in touch with the members between conventions.

The Chapter and Society have given my wife and me the opportunity to visit convention cities that we may never have thought of going to such as New Orleans, Atlanta, Indianapolis, Chicago, Los Angeles (twice), Long Beach, Miami, Kansas City, Phoenix and of course, the Boston Chapter hosted the ASPE Convention in 1982.

The Chapter has been quite successful over the years. We enjoyed being the number one Chapter in the Society for a long time; in fact we were the first Chapter to break the 400 member barrier in 1998. The Chapter has been successful because of the Presidents and their Boards of Directors who were dedicated to the education, welfare and camaraderie of Chapter Membership.

In 1988, the Commonwealth of Massachusetts Plumbing designers received the fantastic news that the newly appointed Chairmen of the Massachusetts Professional Board of Registration Francis J. Linehan, JR., PE announced that qualified Plumbing designers could apply for the Professional Engineers license in the discipline of Plumbing. The Society was so appreciative of Mr. Linehan's landmark decision they brought him to the Washington DC convention and presented him ASPE's highest honor, the George Runkle, PE Award for dedication and advancement in Plumbing, for the Society and its membership.

Membership attendance has always been the focus of any organization. And if that organization is to succeed the membership must become and stay involved or the organization will die, if not infused with new blood, with fresh ideas and the courage and dedication to infuse the fresh ideas into the organization.

I am a Charter member of the Boston Chapter and I must say if it were not for the American Society of Plumbing Engineers and the advanced Plumbing technologies, I might still be a draftsman. I started out in this business a long time ago and by attending college at night to earn my Bachelors degree, the monthly meetings, biyearly conventions and symposia, I was able to advance to designer, engineer, Professional Engineer and finally company Vice President.

Why all this time dedicated to the Plumbing Industry? Why all this time away from my family while they were growing up? I looked at it as an investment for my family's future. Three out of four went to college and owe no tuition; the fourth is a very successful business man. Three out of four got married without taking out a loan; the fourth is too young. Every year we went on vacation first to our cottage in New Hampshire and as they got older, the bigger the vacations became, we traveled to Disney World, Alaska, Caribbean, Bermuda and European Cruises. So the time I invested honing my trade, has paid off in big dividends for my wife, children and grandchildren.

I cannot tell you how important my family is to me or your family to you but education and hard work will lead to more dollars and more dollars means you and me can do more and more for our beloved families.

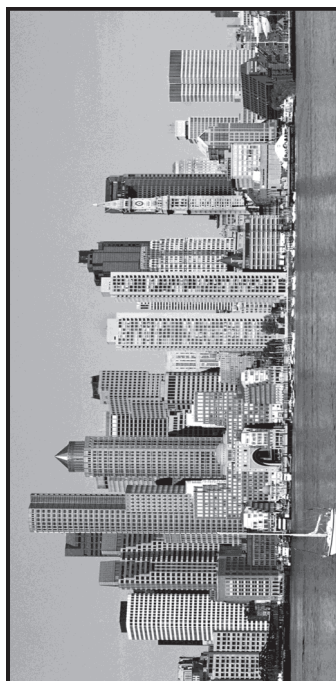

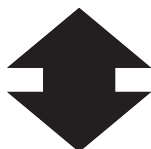

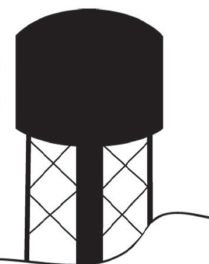
