

### NOTICE!!! FROM CITY OF BOSTON ISD

Please be advised that the city of Boston will only accept a minimum of 2 1/2 inch threaded Fire Department connections for residential sprinkler systems. No quick connection devices allowed. NFPA 13-R and NFPA 13-D suggest minimum sizes for fire Department connections that are not compatible with the Boston fire Department requirement for 2  $\frac{1}{2}$  inch for residential applications. The connection will be reviewed per 780 CMR prior permit issuance as well as field inspected at Certificates Of Occupancy close outs.

#### News from ASPE Society

#### Plumbing Engineering Design Handbook updates:

# Legislative Report

This is a continuation of December 2009 article relating toNFP9 99 Health Care Facilities 2005. Below are a couple of shortened sections of NFPA 99 2005 that were changed or added.

- 5.1.3.5.3.2 Medical air compressor systems shall consist of the following:
- (6) Piping and components between the compressor and the source shutoff valve
- (7) Except as defined in 5.1.3.5.3.2 (1) through 5.1.3.5.3.2(6), materials and devices used between the intake and the source valve shall be permitted to be of any design or construction as determined by the manufacturer.
- 5.1.3.5.4 Compressors for Medical Air.
- 5.1.3.5.4.1\* Compressors for medical air shall be designed to prevent the introduction of contaminants into the pipeline by any of the following methods:
  - (1) Elimination of oil in the compressor (e.g., liquid ring and permanently sealed bearing compressors)
  - (2) Reciprocating compressors with a separation of oil-containing section from the compression chamber by a minimum of two seals creating an area open to atmosphere that allows the following:
    - (a) Direct and unobstructed visual inspection of the interconnecting shaft through openings no smaller than 1.5 shaft diameters in size.
- 5.1.3.5.4.3 Compressors to be constructed of materials manufacturer determine suitable.
- 5.1.3.5.5.1 After coolers to be constructed of materials manufacturer determine suitable.
- 5.1.3.5.7 Medical Air Dryers shall meet the following requirements:
  - (3) Constructed of materials manufacturer determine suitable.
- 5.1.3.5.8 Medical Air Filters. Medical air filters shall meet the following requirements:
  - (5) Constructed of materials manufacturer determine suitable.
- 5.1.3.5.9 Medical Air Regulators. Medical air regulators shall meet the following requirements:
  - (2) Constructed of materials manufacturer determine suitable.



### **DID ANYONE NOTICE?**

I believe the attendants for the meeting was +/- 40 people, that equates to 800 oz. of water not served and an additional 2400 oz. of water not used to wash the glasses. (3 times the glass content for washing) a total of 3200 oz.


 $3200 \times 0.02957 = 94.624$  liters  $\times 0.2642 = 24.999$  gallons of water saved.

In addition coffee was not served. One cup = 8 oz. x 40 = 320 oz. + 24 oz. (for cleaning) = 960 oz. or an additional 10 gallons of water saved for a grand total 35 gallons.




