

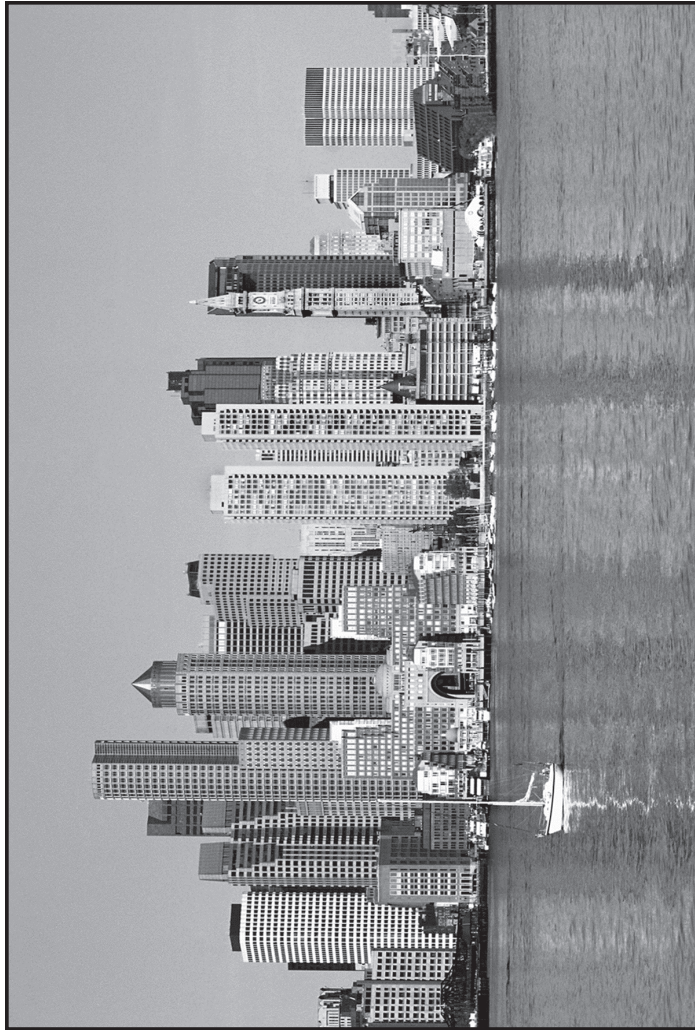

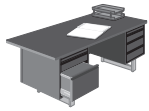

## Technical Report

### November ASPE Boston Chapter Meeting The 2001 World Trade Center Collapses

You are invited to join us for our **November 2012 ASPE Meeting at the Chateau Restaurant located at 131 River Road, Andover MA on Tuesday, November 13, 2012.** This month's meeting will prove to be a must attend seminar in today's evolving world. On September 11, 2001, the world as we know it changed forever. Our technical session will be on the World Trade Center Collapses: The FEMA/ASCE Building Performance Assessment Team's (BPAT) work on the site and the conclusions and report developed in the aftermath of the disaster.

Our speaker is Mr. Robert F. Duval, New England Regional Director and the Senior Fire Investigator at the National Fire Protection Association (NFPA), based in Quincy, Massachusetts. Robert is responsible for conducting investigations of technically significant incidents in order to gather, "lessons learned" from each incident to apply those lessons to improving NFPA codes and standards. The investigation of these incidents includes documenting the emergency services response, the structure(s) involved as well as the events leading up to and following the incident.

Bob spent several days at the World Trade Center site shortly after the September 11th attacks as part of the Building Performance Assessment Team study. He has conducted investigations into many other significant incidents including; fire fighter fatalities in Albert City Iowa, Lake Worth Texas, Marks, Mississippi, New York City, Phoenix, Arizona, Keokuk, Iowa and Coos Bay, Oregon, a cruise ship fire in Miami Florida, a grain elevator explosion in Kansas and a bulk retail warehouse in Phoenix, AZ, among others. Robert was also involved in the 2003 investigations of the tragic Rhode Island nightclub fire that killed 100 people and the Hartford, CT nursing home fire that claimed 16 lives.

Robert was named the New England Regional Manager for NFPA in 2003. In this role, he interfaces with fire and building officials in the New England states on code related issues. Robert holds the rank of Chief in the volunteer fire company in his hometown of Wauregan, CT, where he has been a member since 1981. He has worked as an emergency services dispatcher in a regional fire department dispatch center in northeastern Connecticut since 1986. He also serves on the instructional staff of the Eastern CT Fire Training School. He recently retired from the Connecticut State Fire Academy after 20 years as a staff instructor.

Robert serves as a Communications Specialist for the Connecticut State Urban Search and Rescue Task Force. He is also a member of the CT Region 4 Incident Management Team (IMT - 4). Robert holds a Bachelor's Degree in Mechanical Engineering Technology from Northeastern University in Boston, MA.

Please mark your calendar and join us for this very exciting seminar on the north shore. This is a once in a decade opportunity.

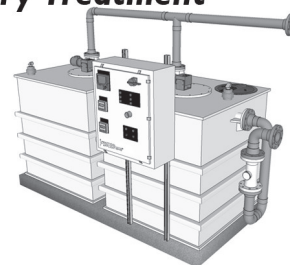

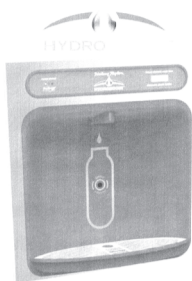

### MA Product Approval Revisions

The following email notification was sent out by the Massachusetts Board of Examiners of Plumbers and Gas Fitters. Just forward-ing this along as an FYI to our Boston Chapter Affiliate members...

To: *Manufacturer & Manufacturer Representatives*  
Re: *Product Acceptance Revisions*

*On August 17, 2012, 248 CMR 3.05 was revised to change Massachusetts "Product Approval" to "Product Ac-  
ceptance". All future references to this process will be addressed in this manner.*

*The Board of Examiners of Plumbers and Gas Fitters at their regularly scheduled meeting on September 26,  
2012 voted to increase the "Initial Product Acceptance" from one (1) year to three (years). The cost associated  
with this has also changed. The old one year fee was \$75.00 per 10 Items. The new three year fee is \$150.00  
per 10 items. This represents a substantial savings for the manufacturer.*

*When filing for a new product, please use the new (FORM A) Initial Product Acceptance Application and (FORM B)  
Product List to request acceptance in Massachusetts, below is a link to the new application and product  
list. Please read and follow the instructions enclosed with the application in order to have your request pro-  
cessed in a timely manner.*

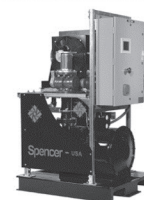



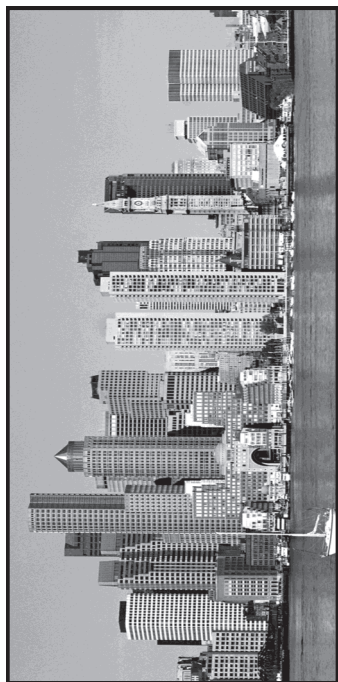
