Legislative Report

Last month's meeting was our Biannual Product Show, it was great to see such a turnout, be introduced to new products and reconnect with a number of you.

At the product show, I was giving the opportunity to sit-in on the Mass Plumbing Code Seminar, presented by Wayne Thomas, Paul Kennedy and Bahig Kaldas of the Massachusetts State Plumbing Board. It was a lively seminar with an underlying question of what is a board policy, where do you find it and how does it relate to the plumbing code?

A board policy can be an official code interpretation, an upcoming code revision currently being enforced or direction concerning a new plumbing technology or product. It should be noted that board policies and code interpretations are not in the plumbing code and can be found on the board's website: <http://www.mass.gov/ocabr/licensee/dpl-boards/pl/board-policies/>. The following is a list of the board's current policies and code interpretations:

Code Interpretations: PVC installation, secondary roof drainage, limited service health clinics, handicap requirements, commercial kitchen hood interlock, overhead garage doors, siphonic roof drainage, So-Vent systems, grease and vacuum drainage systems, definition of plumbing, exception to lining an existing chimney, tentative guidelines for installing and connecting a NFPA 13D systems on a potable water system

Policies: On demand domestic water heaters, chemical clean dispensers, alternate to ASME tanks, corrugated stainless steel tubing (CSST), plumbing product approval procedures, gas fired patio equipment, combination space heating / potable water system, safe waste pans, gas / oil separator alternative, water filtration and water dispensing systems




